**FRAZEE CITY CAMPGROUNDS  
GENERAL RULES AND REGULATIONS**

The City of Frazee governs a Full RV Hook-up campground (110 River Drive South) with four (4) sites and a primitive campground (18 River Drive North) with two (2) sites. Both campground locations are patrolled by the Frazee Police Department. The City of Frazee established campground rules to help make your stay a safe and pleasant experience.

1. All guests must register - Frazee City Hall is located at 222 West Main Avenue and office hours are Monday – Thursday from 7:00 am to 6:00 pm. All campers are welcome to check-in at Frazee City Hall during office hours. City Hall is closed Friday – Sunday. A payment dropbox is located outside City Hall where payments can be dropped if registering outside of office hours.
2. One RV unit is permitted per site. One tent is permitted per site.
3. No wastewater (including gray water) is to be dumped on the ground. Please use the provided dump station located across from the office.
4. Put all garbage in the provided garbage can.
5. No glass bottles allowed. Glass recyclables can be brought to one of the City's two large public recycling dumpster locations.
  - a. Downtown location: behind U-Haul Rental (205 Main Ave West)
  - b. Highway 29 location: In front of Frazee Rescue (513 Birch Ave West)
6. All pets must be on a leash and should not be left unattended. Please clean up after them. Current Rabies information must be provided to staff at the time of reservation.
7. Be courteous to all campers. Visitors must leave the campground by 10 p.m.
8. All fires must be attended. Please do not cut tree branches. Fires are allowed in grills and fire rings only.
9. Quiet hours are from 11 p.m. to 8 a.m.
10. Activities not permitted: Cutting trees or shrubs or bringing in logs from the woods, disturbing wildlife, defacing park property, ATV's operating on park property, controlled substances, and keg beer.
11. We reserve the right to evict, without a refund, anyone who does not respect the campground rules, or does not respect fellow campers.
12. The City of Frazee is not responsible for lost, stolen, or damaged items.
