Attention Bank Payment Users:

If you use your bank's online bill pay system to make city payments:

Many banks send payments as paper checks through the mail (sometimes from out of state), not electronically. This can delay when your payment arrives at the City office.

Please allow extra time for delivery - approving an online bill pay payment on the 30th will not get it to the City office by the 1st of the month. Your payment is only applied once it is received at City Hall, even if your bank shows an earlier transaction date.

Reminder: Payments are due by the **1st of each month**. Penalties are added the next business day if payment has not been received. Have questions? Please contact the City Office—we're happy to help. Thank you!



Notice to Residents

The City of Frazee allows approved individuals and companies to go door-to-door within city limits once they have received a valid City permit.

All solicitors, peddlers, and transient merchants are required to carry a City-issued permit while conducting business in Frazee. Residents have the right to ask to see this permit for verification. Valid permits will display the City logo.

Approved solicitors will be posted on the City's Facebook page with photo identification.
